## Mary R. Fisher Elementary School Enrollment Requirements

### School Entrance Requirements

1. Original Birth Certificate/DCF 603 Form
2. Health Records-Current physical assessments and immunizations
3. Proof of Residency
  - a. Mortgage Document
  - b. Rent/Lease Agreement
  - c. Electric bill with physical address, not a P.O. box
  - d. Driver's License
  - e. Residency Form

If the student will be living with a Thompson resident other than a parent or legal guardian, you will need to get a residency form provided by the school notarized at the Town Hall. For students attending Thompson Public Schools on a Residency Form, a new form must be completed each year, prior to the opening of school.

Please note, residence should be permanent, provided without pay and not for the sole purpose of obtaining school accommodations provided by the school district.

In cases where a child is not living with a parent, proof of custody must be shown in the form of court documentation.

4. Release of Records Form signed if transferring from another school.
5. Completed Registration Form Signed
